The above-mentioned products sold by the parties have been tested, and the motor code, pedal riding ability, saddle tube safety line, reflector, flame retardant performance, instruction manual and other items inspected do not comply with GB17761-2018 "Safety Technical Specifications for Electric Bicycles" requirements, and deliberately concealed illegal facts during the investigation. According to Article 27 of the "Measures for the Implementation of Administrative Punishment Discretion of the Beijing Municipal Administration for Industry and Commerce" (Trial Implementation): "If the party involved has any of the following circumstances, he may be given a heavier administrative penalty: " Item (1): "Implementing serious harm Social stability, personal health, life and property safety; "should be severely punished.
