The applicant Guangdong Guobi Technology Co., Ltd. applied for enforcement of the case of your unit's contract dispute, because your unit failed to perform within the period specified in the notice of enforcement. The payment obligation determined by effective legal documents shall be determined by this court in accordance with Article 255 of the "Civil Procedure Law of the People's Republic of China" and Articles 1 and 1 of the "Several Provisions of the Supreme People's Court on Restricting High Consumption and Related Consumption of Persons Subject to Execution". According to the provisions of the three articles, take measures to restrict consumption for your unit, restrict your unit and your unit (legal representative, main person in charge, directly responsible personnel affecting debt performance, actual controller) Cheng Xingwen must not implement the following high consumption and non-life Consumption behaviors necessary for work and work: (1) When taking transportation, choose airplanes, soft sleepers on trains, and second-class or higher cabins on ships; ) Purchase of real estate or newly built, expanded, or high-end decoration houses; (4) Lease of high-end office buildings, hotels, apartments and other places for office work; (5) Purchase of vehicles not necessary for business operations; Schools; (8) paying high premiums to purchase insurance and wealth management products; (9) taking all seats on EMU trains with the prefix G, first-class or higher seats on other EMU trains, and other consumption behaviors that are not necessary for life and work. If your unit (legal representative, main person in charge, person directly responsible for affecting debt performance, actual controller) implements the aforementioned acts with personal property for private consumption, you can file an application with this court. If your unit conducts the above-mentioned prohibited consumption activities due to business needs, it should submit an application to this court, and it can only be carried out after approval. If the violation of the consumption restriction order is verified to be true, the court will impose a fine and detain it in accordance with the provisions of Article 111 of the Civil Procedure Law of the People's Republic of China; if the circumstances are serious enough to constitute a crime, criminal responsibility shall be investigated according to law.
